



The Agility Connection Five (5) Year Plan

Background: When TAC planned the dates we wished to host AAC sanctioned trials in 2007, we carefully considered what was being offered locally and chose dates accordingly so as to avoid conflicts as well as choosing dates that suited our own "TAC family".

The 2007 dates, approved by AAC, were:

Saturday, June 30th and Sunday, July 1st

Saturday, August 4th and Sunday, August 5th

Saturday, September 22nd and Sunday, September 23rd

TAC's Five (5) Year Plan is to host AAC sanctioned trials to coincide with these historical dates, i.e. dates established in 2007, pending AAC's approval as per rule 2 - 2.1... APPLICATION TO HOST AN AAC SANCTIONED AGILITY TRIAL "...For clubs who have hosted trials in the past, trial applications may be submitted without judge and class information up to one year prior to the date of the trial...". TAC intends to apply to AAC to host trials each year as follows:

1. the first weekend in July (to coincide with the July 1st holiday whenever possible),
2. the first weekend in August (i.e. the Civic Holiday weekend) and
3. the second last weekend in September each year.

Pending approval from the City of Kingston, it is TAC's intention to continue to host AAC sanctioned trials at Lake Ontario Park each year. This is a central city location, right on the shores of Lake Ontario, close to amenities with a water source for cooling and plenty of shade. The grounds are well maintained and lovely for all!
