I (we) agree that the club hosting this event, The Agility Connection, has the right to refuse this entry for cause, which the organizing committee shall deem to be sufficient. ### Refunds:

*There shall be no refunds for the following:*

- In the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal.
- In the event of inclement weather.

*Refunds will be issued for bitches that come into season, or dogs who are injured, **providing** the Trial Secretary receives a veterinarian's certificate at least 24 hours before the start of the trial.*

**Move Ups:** PLEASE advise the Trial Secretary in writing of any move ups prior to the final confirmation (5 days prior to the trial). Move-ups shall also be permitted during the trial. A move-up sheet will be provided.

**Confirmations:** A confirmation of your entry will be emailed to each competitor after it has been processed & payment has been received. Cheques may be cashed at any time after the closing date.

### Awards:

Placement Ribbons (1st through 4th place), Qualifying Ribbons for CARO qualifiers, and Title Rosettes for dogs that achieve CARO Titles will be awarded with placements following completion of each event.. A title sheet will be provided.

### Facilities: BIG SKY DOG CENTRE

- The trial will be held indoors, in a heated hall with turf flooring. This is a one-ring event.
- No outdoor shoes can be worn inside the hall. Only a change of shoes is permitted inside or bare feet.
- No crating is available inside the building.
- Competitors are responsible for their own crating, seating, food & water.
- Self-serve coffee and tea will be available.
- There is no lunch provided, so please pack your own lunch as there's no place close to buy lunches or snacks.
- Port-a-potty is available.

### Dogs:

- No bitches in season will be allowed to compete or on site. Competitors that attempt to compete with a bitch in season will have the bitch excluded from the event with no reimbursement of funds.
- All dogs must be kept in an x-pen, crate or on leash when not in the ring. There is no crating in the building.
- Handlers are responsible to keep their dogs quiet at all times.
- Handlers are responsible to clean up after their dogs.
- Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds. There will be no refund of fees in such instances.
- Any handler displaying inhumane or aggressive treatment of any dog, physically or verbally, while on site, will be asked to leave the trial grounds. There will be no refund of fees in such instances.

#### Travelling from the West (Belleville to Kingston) - Via Hwy. 401 East:

- Take exit 599 for Wilton Road, Yarker.
- Turn left onto Wilton Road 6, heading north
- Continue for approximately 10 minutes
- Turn right onto Route 20, Wilton Road
- Turn right onto **Florida Road** and continue until **4445 Florida Road**

#### Travelling from the east (Brockville to Kingston) - Via Hwy. 401 West:

- Take exit 611 for County Road 38, Harrowsmith.
- Turn left onto Highway Road 38, heading north
- Continue for approximately 12 minutes
- Turn left onto Yarker Road
- Take the 1<sup>st</sup> left onto Henderson Road.
- Take the 1<sup>st</sup> left onto **Florida Road** and continue until **4445 Florida Road**
